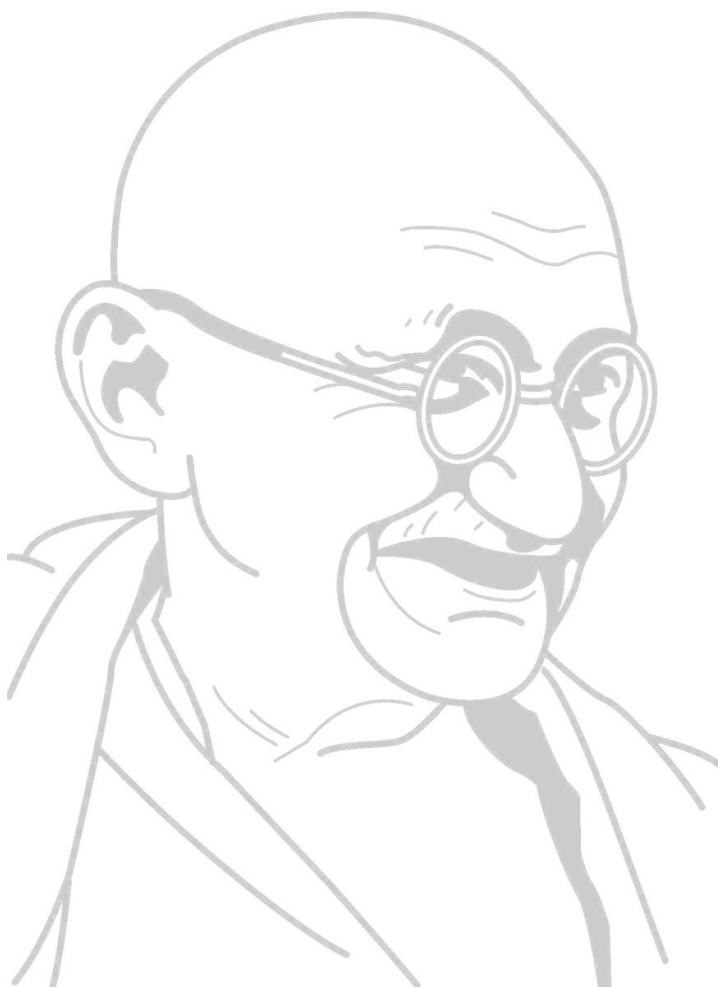

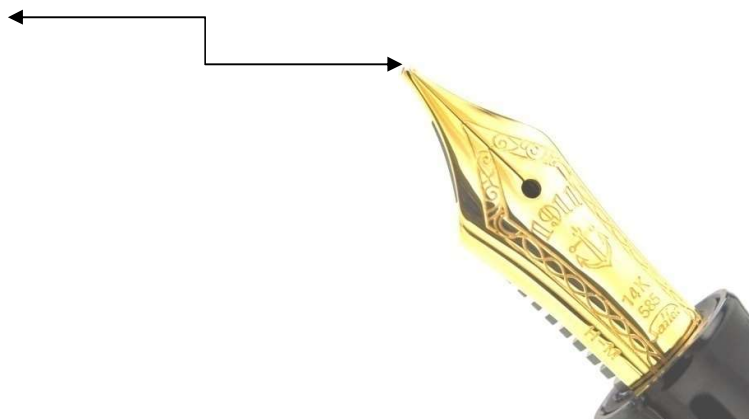

Indian Education Commission (1882), popularly known as Hunter commission also recommended the introduction of practical subject in secondary schools Mahatma Gandhi, for the first time, insisted that manual and productive work should not be an integral part of education but should centre round it. The Education commission (1964-66) also recommended a 10 – year schooling and diversification into two streams – academic and vocational of plus 2.
